# PRIVACY POLICY

This privacy policy governs your use of the software application HistologiQuiz ("Application") for mobile devices that was created by Mikkel Bo Brent. The Application is a quiz in human histology based on Genesers histologi 1st edition by Annemarie Brüel et. al.

What information does the Application obtain and how is it used?

#### **User Provided Information**

The Application obtains the information you provide when you download and install the Application. Installation of the Applications is mandatory to be able to use all features included in this app.

The information obtained includes in In-app purchases, the ability to read device & app history including sensitive log data, the ability to read phone status and identity.

Information pertained to photos/medias/files includes the ability to read the contents of USB storage, the ability to modify or delete the contents of the USB storage. This is done to ensure that questions which includes pictures work properly.

Information pertained to storage includes the ability to read the contents of USB storage, the ability to modify or delete the contents of the USB storage. This is done to ensure that questions which includes pictures work properly.

Information pertained to device ID and call information includes the ability to read the phone status and identity.

Furthermore, the Application can view nearby Wi-Fi connections, receive data from the Internet and view network connections. The Application also has full network access and can prevent your device from sleeping.

## **Automatically Collected Information**

In addition, the Application may collect certain information automatically, including, but not limited to, the type of mobile device you use, your mobile devices unique device ID, the IP address of your mobile device, your mobile operating system, and information about the way you use the Application.

## Does the Application collect precise real time location information of the device?

This Application does not collect precise information about the location of your mobile device.

# Do third parties see and/or have access to information obtained by the Application?

Only aggregated, anonymized data is periodically transmitted to external services to help us improve the Application and our service. We will share your information with third parties only in the ways that are described in this privacy statement.

We may disclose User Provided and Automatically Collected Information:

- When we believe in good faith that disclosure is necessary to protect our rights, protect your safety or the safety of others, investigate fraud, or respond to a government request;
- With our trusted services providers who work on our behalf, do not have an independent use of the information we disclose to them, and have agreed to adhere to the rules set forth in this privacy statement.

#### What are my opt-out rights?

You can stop all collection of information by the Application easily by uninstalling the Application. You may use the standard uninstall processes as may be available as part of your mobile device or via the mobile application marketplace or network.

## **Data Retention Policy, Managing Your Information**

We will retain User Provided data for as long as you use the Application and for a reasonable time thereafter. We will retain Automatically Collected information for up to 24 months and thereafter may store it in aggregate. reasonable time. Please note that some or all of the User Provided Data may be required in order for the Application to function

properly.

### Security

For example, we limit access to this information to authorized employees and contractors who need to know that information to operate, develop or improve our Application.
